Plan S

- Purpose - accelerating the transition to open access
- 13 countries / signatories of *cOAlition S*
- All data and results of research financed by the research funding bodies (ex. *National Science Centre* in Poland) must be published open access

- So far: a declaration
- The signatories will negotiate with HE institutions on their OA local policies
- First: journal papers, financed by grants, the same fees in EU; monographies – a next step
- Publication in OA should be included in a grant application

for ex.: Austrian Science Fund (FWF): max. EUR 2,500,000 per OA in Golden OA; max. EUR 1,500,000 – in Hybrid OA

Constitution for Science. Poland

- October 1st, a new Act on Higher Education
- Law 2.0 / Reform 2.0
- According to its authors, it brings Polish science an opportunity for a pro-quality development and visibility in the world
- It draws new challenges, particularly for Humanities and Social Sciences (HSS), as well as new outlooks for Polish scholarly communication

The Constitution for Science emphasizes that scientists should publish in scientific journals included in international databases, which will help scientists from around the world find this content.

Such publications will be scored higher.

The Ministry of Science will launch a new program to help more Polish scientific journals enter such databases.

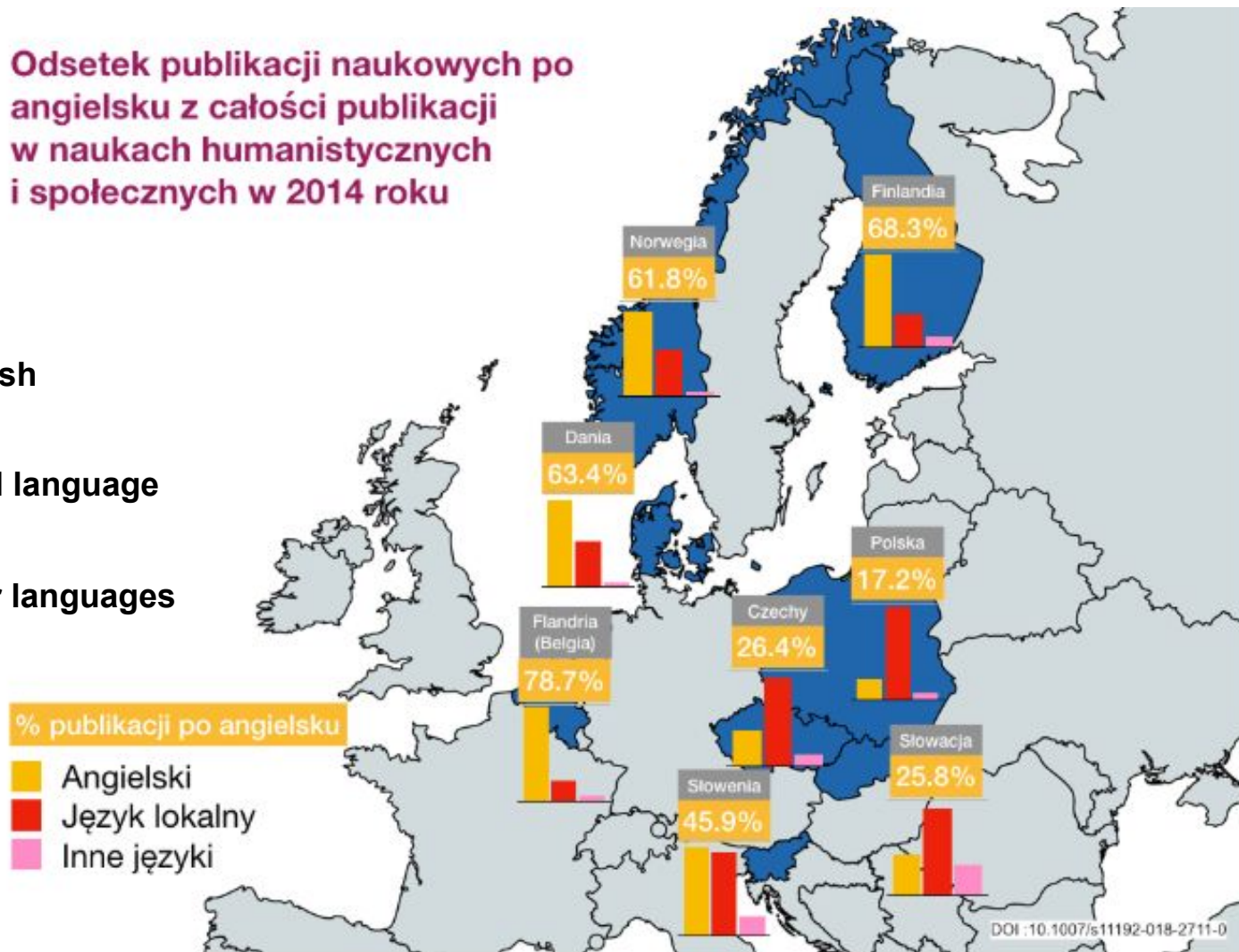
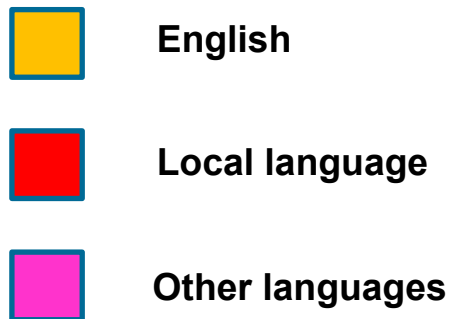

Abstract This study investigates patterns in the language and type of social sciences and humanities (SSH) publications in non-English speaking European countries to demonstrate that such patterns are related not only to discipline but also to each country's cultural and historic heritage. We investigate publication patterns that occur across SSH publications of the whole of the SSH and of economics and business, law, and philosophy and theology publications in the Czech Republic, Denmark, Finland, Flanders (Belgium), Norway, Poland, Slovakia, and Slovenia. We use data from 74,022 peer-reviewed publications from 2014

- **New classification of disciplines** (Information Science - a subfield of Media and Communication)
- Each scholar may declare max. 2 disciplines
- **Discipline-based evaluation of research units** (4 achievements / 4 years)
- **SciVal** - the tool for scholarly evaluation

Ranking of Scholarly Publishers

- **Launched on January 18, 2019**
- **536 publishers, two categories, points received for monographies**
- **200 points - huge international publishers (Oxford, Harvard, MIR, Routledge, SAGE...)**
- **80 points - smaller publishers, but also... Springer**

- **More is unknown than is known**
- **A real test – academic year 2019/2020**
